




## 2018-2019 Film Series


derision to one that is enthusiastically



## The Continued and Urgent Need for Skills-building for Healthy Congregations ~Sharon Kniss

After I graduated with a Justice, Peace, and Conflict Studies degree, I began working for Bridge Builders – an ecumenical ministry based in London, England with an expressed mission to "transform church conflict." Our organization provided training for church leaders throughout the UK in handling conflict – from interpersonal disagreements, to strategic planning and structural change, to transforming the entire church culture to be one that could handle conflict well.



We also provided consultancy, mediation, and facilitation support for congregations that found themselves in conflict.

Having graduated with ideals about how exciting it would be to

support a peace process in Colombia or end street violence in the US, I chuckled that my daily work was instead "teaching church leaders how to love each other" – a basic tenet of the Christian faith. And yet, I also realized, if the Church can't do this (a body which is formed based on this expressed value) – then what hope is there for anyone else?

I've continued to support congregations in this important work throughout my career. In my first year at KIPCOR, we received 2-3 enquiries for congregational support, none of which transpired at the time into further engagement. In the last 18 months, we have received 10 • enquiries and have worked actively with 7 congregations in some capacity.

I'm not sure if there's a particular reason for the uptick in enquiries and requests recently, since the challenges in the congregations run the gamut: a crisis incident that throws a congregation off-balance, "safe and welcoming" concerns relating to policies surrounding sexual abuse and offenders, rumor-mills coupled with leadership concerns, ingrained patterns of communication and behavior leaving the congregation barely holding on together, articulating theologi cal approaches to political concerns, scapegoating, and more. At the same time, I know our faith communities are not isolated islands - they reflect and respond to wider society's concerns. The polarized national political climate seeps into our communication patterns with each other, pushing us to either be silent to not rock the boat, or speak too harshly out of our passion. The #MeToo movement has likely contributed to more voices willing to speak out and push congregations to better address safety concerns around sexual abuse and harassment.

With only a few staff members and associates, KIPCOR doesn't have the capacity to adequately support all the requests we receive while maintaining our other educational and case commitments. Therefore, two key needs emerge with urgency as we seek to continue supporting healthy congregations:

 We need to equip more congregations, with their ordained and lay leaders, to address conflict, crisis, and change in healthy and productive ways.  We need to increase the pool of outside facilitators ready to support congregations when they enter difficult periods or crises.

There are two ways we are addressing these needs: In a few weeks, January 3-4, we offer our semi-regular training course on "Managing Difference & Disagreement within Faith Communities" which will offer more skills and insights for building healthy(ier) congregations. Please consider signing up 2-3 members of your congregation to attend and learn these skills and insights to take back and help transform your community. We currently have too-few registrants to run the class, but we don't want to have to cancel because we know these skills are needed in our congregations!

Secondly, the skills used in supporting congregations are diverse - group facilitation, mediation, strategic planning, community organizing, systems theory, organizational development, trauma healing, and restorative justice are all skill sets I have used in working with congregations. In addition to schooled training, a lot of my learning came from practice and mentorship because of the unique dynamics in congregational life. Recognizing this, I'm interested in mentoring colleagues who feel called to support this work, particularly young people of color who see themselves as potential leaders in this field.

I know there is hope for our faith communities to lead the way in transforming relationships and communities to be healthy and vibrant, even in the face of conflict. Join us in this important work!

## **Bringing KIPCOR Skills to Everyday Situations**



COR hosted its first "Core Skills" session. The idea for the Core Skills sessions had been perco-

lating for a few years. While KIPCOR staff are deep in the sea of conflict resolution, we realize there are many people in our communities who are not swimming in the sea and do not have these skills as their "go-to" responses as alternatives to a fist or altercation. Yet at the same time, most of those people are unable to access (due to time, resources, or awareness) a formal mediation or conflict resolution training to build their everyday skill sets. Additionally, since the 2016 election, people are increasingly exclaiming over social media and in person, "I just don't know how to have a civil conversation with them!" as our polarized politics began dividing our

friendships and acquaintances. We immediately felt a burden of need, because this is what KIPCOR does.

So we designed a new series – with the explicit goal of accessibility. We wanted to make our "bread and butter" skills what we're using constantly with groups and people in conflict and in our classes available and shared in manageable pieces for those who needed some extra skills in their pocket for everyday use.

The sessions offered this fall and spring (2018-2019) are a pilot run. We need to see what people are interested in, whether they will travel beyond their immediate community for the training, whether the trainings are accessible enough. how to ensure affordability, and ultimately how to best respond to the needs in communities for more skills. We hope you'll join us for this experiment, invite your friends (or enemies!), learn a new skill, and be part of our collective effort for more healthy communities and relationships, even in times of polarization.
